#### Where do I store information?

I will store any personal information you provide securely and will control who has access to it. I do not use hard copy documents and electronic documents and your contact details will be stored securely on a password-protected cloud service. I will not store your phone number in a phone.

If you fill in a form on my website, that data will be temporarily stored on the web hosting site before being sent to me.

At the end of our work together, I will securely retain your contact details for seven years; this is standard data protection. At the end of this period, your details will be fully deleted.

I will appoint a responsible person to contact you in the event of my incapacity or if I am involved in an emergency.
